


Indiya Aaj



Another illegal sex trafficking centre has been shut down!

(Photo to below) the photos on the left are of confirmed sex traffickers, the police is requesting the help of the public to capture these criminals. The police are asking the public to report sightings of these people to the Indian police service. * call 100, if you are to see any of these people.*



(Photo on left) the photo above displayed the "happy house" where many girls (including but not limited too (Lakshmi, Shanna, Monica, Pushpa and Anita. [last names are not displayed for the security and safety of the girls]) they were forced to participate in acts of prostitution for multiple years.

Over the past few days
the police have been
arresting and questioning
officers who allegedly
accepted bribes from
multiple sex trafficking
centres. (including but not
limited to, happy house,
rainbow room, joyous
residence...)

According to "happy house" owner she started it as a way to make money after she lost her job. She said, "I did it to survive, you try making money in this economy."

It is suspected that the bribes were exchanged to stop the sex trafficking centres from being exposed to the police radar.

The "happy house" as called by Mumtaz (owner), Lakshmi (worker), and Pushpa (long time / evicted worker). Was shut down over the weekend, with the help of an American human rights company (hope house).

After many raids by the Indian police service and no sure proof of any young female residents, the Indian police service stoped accepting "tips" from people claiming there was 6+ girls and women in forced, illegal sex trafficking taking place at the residence.

After multiple days of planing the American human rights company (hope house), and loyal Indian police service officers, [more information on page 2] set up a raid and successfully arrested the owner. thanks to photo evidence provided by an American from the human rights service (hope house).

The owner (mumtaz, [last name not included for security purposes]) has refused to make a statement involving the "happy house" and the young girls.

Though the police and human rights company have relished news that she will be receiving jail time and restrictions involving her relations to other young women and girls. As well there will be consequences for bribery to government workers [more information on page 2]

It is expected that she will have a minimum of 3 years since there were girls as young as 12, working for owner, mumtaz.

Recently the editor of *indiya aaj*, had an exclusive interview with Lakshmi a surviving resident of the happy house, she shared her story of how she worked everyday to survive.

Interviewer:

How did you end up at the happy house?

Lakshmi:

My family lived in the rural mountains of Nepal. After my father died, my AMA married my step father. He liked to gamble, which made it difficult for my family to afford things like food and a new roof for our home. One day my AMA got very ill so my step father sent me to be a maid in the city, instead of becoming a maid, i became a worker in forced prostitution. I did what i had to do for my family to survive.

Interviewer:

What was it like to be in the "happy house"?

Lakshmi:

It was scary, i had never been so scared in my entire life... the owner (mumtaz) threatens to hurt me if i did not work. She beat me and cut off my hair when i tried to run away. She used crushed chilies as a punishments... she lied so i would have to stay longer. I did what i had to do so she would not hurt me or let me die...

Interviewer:

Was it all bad?

Lakshmi:

No, the girls were nice. We laughed at times, we watched the television. But you never forgot where you were. Eventually the "fun" stoped and the work started.

Interviewer:

How are you recovering?

Lakshmi:

Slowly, I survived. I did not get too sick where I could not work. When I got a cold... she threatened to throw me out on the street... she said I was lucky to be there, I had to work to survive.
